Kwadjo Adjepong

Kwadjo Adjepong is a senior enforcement lawyer at the Competition and Markets Authority, with a track record in leading investigations, enforcement cases and arbitrations within a regulatory, ethics, disciplinary and tribunal context. He has previously worked at the Serious Fraud Office, the Financial Conduct Authority, the Financial Reporting Council and Goldman Sachs, where he was an Executive Director. Kwadjo has been appointed to a number of sports disputes and disciplinary panels at the Court of Arbitration for Sport, UK Sport, the LTA, the Premier League, the EFL and the FA. He is also a member of the Sport Resolutions Panel of Arbitrators and Mediators and an independent Chair of the UK Sport Eligibility Panel. Kwadjo is a former athlete and has been part of UKA's Focus Group on Diversity and Inclusion.

Dawn Allan is Head of Operations at scottishathletics where she leads on finance, HR, IT and governance matters, having previously held a number of finance roles within construction, IT and transport.
