



**2026 WORLD ATHLETICS INDOOR CHAMPIONSHIPS: 20 - 22 MARCH 2026,  
KUJAWY POMORZE, POLAND**

**SELECTION POLICY – published December 2025**

Updated February 2026 – Amendment to paragraph 10, Appendix 1

This Selection Policy (“the Policy”) set outs the selection process for the team to represent Great Britain & Northern Ireland at the 2026 World Indoor Athletics Championships (“the Championships”) in track & field.

Athletes should note that they must comply with all General Eligibility Requirements given in Appendix 1 to compete for Great Britain & Northern Ireland at these championships. **New World Athletics Female Athlete Category Testing (‘FACT’) is now an Eligibility Requirement. Female athletes should note that they must have an SRY Gene Test in order to be Eligible to compete - see Appendix 1, paragraph 2.**

**Please note:** There is a shorter qualification period for this Championships than the World Athletics window in order to accommodate all necessary procedures. Athletes should carefully review the dates in paragraph 9b to ensure they meet the Qualification Requirement.

**PERFORMANCE OBJECTIVE**

- To maximise medal success and top 8 placings at the Championships

**IMPORTANT NOTE FOR COMBINED EVENTS ATHLETES**

Combined Events are invitation only from World Athletics (WA). In order to comply with WA rules, athletes must email the Performance Director ([pdunn@britishathletics.org.uk](mailto:pdunn@britishathletics.org.uk)) and Maddy Ibbett ([mibbett@britishathletics.org.uk](mailto:mibbett@britishathletics.org.uk)) no later than **19 December 2025** if they wish to be considered.

**SELECTIONS**

1. The selection meeting will take place on **5 March 2026**.
2. Selections will be based on the performance objectives of the Championships as stated above.
3. Selections will be published by **5 March 2026**.
4. Selections will be subject to the maximum number of entries as follows:
  - a. **All Individual Events**  
A maximum of two (2) athletes can compete per individual event.
  - b. **Wild Cards**  
2026 World Indoor Tour Champions will be invited to participate as a Wild Card, in the same event, in addition to the maximum of two (2) athletes per event.
  - c. **Relays**  
In the 4 x 400m relay, up to four (4) athletes may be selected in addition to any individual athletes selected in the 400m. Relay teams will only be selected if in the Selection Panel’s opinion, the relay team has genuine medal potential at the 2026 World Indoor Championships.

Athletes selected in the 4 x 400m relay, will also be expected to be available to compete in the 4 x 400m mixed relay.

## ELIGIBILITY FOR SELECTION

5. In addition to meeting the General Eligibility Requirements in Appendix 1, to be eligible for consideration for selection, athletes must comply with both Requirement One (Participation at UK Athletics Indoor Championships) and Requirement Two (Qualification).
6. For the avoidance of doubt, complying with the General Eligibility Requirements and both Requirements One and Two means an athlete can be considered in the Selection Process; it does not guarantee selection.

## REQUIREMENT ONE: PARTICIPATION AT UK ATHLETICS INDOOR CHAMPIONSHIPS

7. Save for the provisions set out in Section 8 below; to be considered for selection all athletes must compete in their corresponding event at the UK Athletics Indoor Championships:
  - a. **UK Athletics Indoor Championships** – 14 & 15 February 2026 at the Utilita Arena, Birmingham.

### 8. Specific Provisions

Athletes should review the following provisions carefully before entering the UK Athletics Indoor Championships.

- a. Athletes wishing to be considered for selection in the 4 x 400m relay events must compete individually in the 200m, 400m or 800m.
- b. Combined Event athletes must compete in at least one relevant event, as agreed with the Performance Director.
- c. **‘Doubling Up’**  
For Eligibility purposes, athletes seeking selection in two individual events will not be required to compete in their second event at the UK Athletics Indoor Championships. However, the Selection Panel will have sole discretion to determine whether athletes will be selected to compete in more than one event. The Selection Panel will assess the potential impact a secondary event will have on an athlete’s performance in both events and the Selection Panel has the sole discretion to not select an athlete in a second event in any of the Selection Rounds. Requests to be considered for selection in two individual events (‘doubling-up’) should be made to the Performance Director [pdunn@uka.org.uk](mailto:pdunn@uka.org.uk) in writing **in advance of the UK Athletics Indoor Championships**.
- d. **Illness and/or Injury Exemption**  
In the event an athlete is unable to compete at UK Athletics Indoor Championships due to illness or injury, the athlete must comply with the following conditions. Where the provisions and conditions are not adhered to, an exemption for non-attendance at the UK Athletics Indoor Championships will not be granted. Any exemption will be by exception and is given at the sole discretion of UKA.
  - i. **Illness or Injury earlier than the day before the UK Athletics Indoor Championships**  
- must be evidenced by a medical note from a GP, emergency doctor or consultation with a UKA doctor ([jbrown@britishathletics.org.uk](mailto:jbrown@britishathletics.org.uk)) for that athlete to remain eligible for

selection. The Performance Director and UKA Lead Doctor will at their discretion determine whether, on the basis of the evidence available to them and information provided by the athlete to accept their non-attendance at the UK Athletics Indoor Championships. Failure to satisfy the above will result in the athlete not being considered for selection.

- ii. **Illness or Injury the day before or the day of the UK Athletics Indoor Championships** – the athlete must contact the Performance Director or UKA Lead Doctor as soon as possible prior to the commencement of the relevant event. Detailed information and evidence must be provided by a medical note from a GP, emergency doctor or consultation with the UKA Lead Doctor, in order for the Performance Director and UKA Lead Doctor to assess whether absence from the UK Athletics Indoor Championships is warranted and whether an exemption is granted.
- iii. **Illness or Injury that occurs at the UK Athletics Indoor Championships** – must be reported at the event to the Performance Director and the lead UKA Doctor and must be evidenced with a consultation with the UKA Lead Doctor or a medical note from a GP or an emergency doctor following the UK Athletics Indoor Championships and before the selection meeting on 5 March 2026. The Performance Director and UKA Lead Doctor will assess whether absence from the UK Athletics Indoor Championships is warranted and whether an exemption is granted.

## REQUIREMENT TWO: QUALIFICATION

- 9. To be considered for selection, athletes must also meet a qualification requirement for their corresponding event by **one** of the following routes:
  - a. Be a 2026 World Indoor Tour Champion who has been given a ‘Wild Card’ entry by World Athletics
  - b. For all individual events, achieve the **World Athletics Entry Standard** as set out in the table within the qualification period **1 November 2025 to 4 March 2026**. The World Athletics Entry Standards must be achieved in competitions that comply with the Performance Conditions outlined in Appendix 2.

- c. Be on the World Athletics Top Performance List either ‘**In Top List**’ or ‘**Next best by Top List**’ positions on the ‘Road to Kujawy Pomorze’ at the time of the selection meeting on 5 March.

Athletes then selected must be in a Top Performance List qualifying position at the close and final publication of positions on 11 March in accordance with WA rules.

- d. For Combined Events, be in the fourteen (14) athletes who receive an invitation from World Athletics based on the World Rankings published or receive a Combined Events discretionary invitation from World Athletics following athlete expression of interest.
- e. For Relay Events, there is no qualification requirement.

## SELECTION PROCESS

10. The Selection Panel (the “Selection Panel”) will only select from athletes who meet the General Eligibility Criteria and both Performance Requirements One and Two.

11. Selection will be made in four (4) rounds conducted as outlined below.

- Round 1 – WA Wild Cards & Previous Medallists
- Round 2 – Athletes with a World Athletics Entry Standard
- Round 3 – Athletes on the ‘Road to Kujawy Pomorze’ Top Performance List
- Round 4 - Relays

12. Athletes should note that selection in all rounds is subject to the Selection Panel’s expert assessment of the athlete’s injury and health status.

13. In its assessment of an athlete, or where UK Athletics does not have the capacity or appropriate resources to provide the level of health-related support required, the Selection Panel may decide not to select an athlete if UK Athletics’ medical advice considers that participation would pose a risk to the athlete’s health or the safety of others.

14. The Selection Panel may in its sole discretion set conditions of selection, which may include but are not limited to fitness, health-related or any other form of assessment. In the event the athlete fails to comply with the conditions, the provisions for deselection as set out below may apply.

### 15. Round 1 – WA Wild Cards & Previous Medallists (See Appendix 3)

Subject to an assessment of health and injury status, athletes who meet the criteria below will be selected in their corresponding event.

- a. 2026 World Indoor Tour winners who have been given a ‘Wild Card’ by WA
- b. 2025 World Indoor Championships individual medallists
- c. 2025 World Championships individual medallists
- d. Combined Event athletes who receive an invitation from World Athletics.

The Selection Panel may choose not to select an athlete if the Selection Panel considers that their health or injury status means that the athlete’s ability to fulfil the performance objectives of the championships is compromised.

### 16. Round 2 - World Athletics Entry Standard

- a. If places remain by event, the Selection Panel will consider athletes with a World Athletics Entry Standard.
- b. The Selection Panel will select athletes who have demonstrated the ability to achieve the Performance Objective. The Selection Panel may in its sole discretion decide not to select athletes if in the Selection Panel’s expert opinion, the athletes are unlikely to achieve the

performance objective. To make this assessment, the Selection Panel will consider the following criteria.

- Consistency of performances at or close to the WA qualification standard during the qualification window, with particular emphasis on the 2026 indoor season.
  - Position on the ‘Road to Kujawy Pomorze’ Top Performance List’ at the time of the selection meeting
  - Recent Head-to-heads with other Eligible Athletes (2025 and 2026 indoor and outdoor seasons)
  - Performance and position at the UK Athletics Indoor Championships in the event the athlete is being considered for
  - Demonstration of ability to perform in major international championships since 2024
  - Medical, injury and other health-related status considerations
  - Where ‘doubling up’ is concerned, the impact of competing in multiple events on the athlete’s ability to meet the Performance Objectives of the Championships
  - Other factors the Selection Panel deem relevant.
- c. The criteria above are not listed in order of priority and may be weighted as necessary to best meet the Performance Objectives or may not be considered as the Selection Panel deems appropriate.
- d. If there are more Athletes who have the ability to fulfil the performance objectives of the Championships than there are places available, athletes will be considered for selection based on the Selection Panel’s comparative assessment of athletes who have a World Athletics Entry Standard.
- e. For the avoidance of doubt, the Selection Panel is neither obliged to select athletes nor to fill all event places.

**17. Round 3 – World Athletics Top Performance List position**

- a. If there are places remaining, the Selection Panel will then consider athletes who at the time of the selection meeting appear on the on the ‘Road to Kujawy Pomorze’ either ‘**In Top List**’ or ‘**Next best by Top List**’ positions. Inclusion on this list does not guarantee selection.
- b. The Selection Panel will consider whether the athletes have demonstrated the ability to achieve the Performance Objective. The Selection Panel reserves the right to not select athletes if in the Panel’s expert opinion, they are unlikely to achieve the performance objective. To make this assessment, the Selection Panel will consider the following criteria.
- The gap to the WA qualification standard of performances and consistency of performances close to the WA qualification standard during the qualification window with particular emphasis on the 2026 indoor season.
  - Position on ‘Road to Kujawy Pomorze’ at the time of the selection meeting
  - Recent Head-to-heads with other Eligible Athletes (2025 and 2026 indoor and outdoor seasons)
  - Performance and position at the UK Athletics Indoor Championships in the event the athlete is being considered for
  - Demonstration of ability to perform in major international championships since 2024
  - Medical, injury and other health-related status considerations

- Where 'doubling up' is concerned, the impact of competing in multiple events on the athlete's ability to meet the Performance Objectives of the Championships
  - Other factors the Selection Panel deem relevant.
- c. The criteria above are not listed in order of priority and may be weighted as necessary to best meet the Performance Objectives or may not be considered as the Selection Panel deems appropriate.
- d. If there are more Athletes who have the ability to fulfil the performance objectives of the Championships than there are places available, athletes will be considered for selection based on the Selection Panel's comparative assessment of athletes.
- e. For the avoidance of doubt, the Selection Panel is neither obliged to select athletes nor to fill all event places.
- f. For Athletes selected in this Round, their selection will be subject to the athlete qualifying by virtue of their final Top Performance list positioning on Wednesday 11 March as part of the Qualification Requirement for Eligibility.

**18. Round 4 - Relay Events**

- a. A maximum of four (4) athletes may be selected for each of the 4 x 400m relay events, all of whom will also be expected to compete in the Mixed 4 x 400m.
- b. Relay teams will only be considered for selection if, in the Selection Panel's expert opinion, there is the genuine potential to achieve a medal.
- c. The Selection Panel may choose to prioritise one relay team over another i.e. the mixed relay team above the men's or women's 4 x 400m relay team, to maximise the chance of medal success. The Selection Panel is not obliged to select a team for any or all relay events.
- d. When considering relay events and corresponding individual events, the Selection Panel will select athletes for the event where they have the most opportunity to maximise medal success. This may result in an athlete being selected for the relay event only.
- e. Athletes being considered for relay selection in their respective events will be assessed by the Selection Panel using the criteria below.
- Performance and performance consistency assessed against using the appropriate WA individual qualification standards (including gap to the WA standard) during the qualification window.
  - Current form during the 2026 indoor season
  - Position in WA the 'Road to Kujawe Pomorze' Top Performance List in relevant events at the time of the selection meeting
  - Performance at the UK Athletics Indoor Championships
  - Head-to-heads with other relevant athletes
  - Specific relay skills as assessed in training and in competition including but not limited to: consideration of the team make-up and other athletes selected (adaptability, ability to execute a particular leg), relay flat speed performance, check mark discipline, consistency of performance in key relay elements as determined by the Selection Panel.
  - Recent athlete performance history as part of the relay in championships since 2023
  - Contribution and commitment to relay team-based training/competition activity

- Medical, injury and health-related status
  - Where relevant adherence to the WCP Relay Programme
  - Other factors the Selection Panel deem relevant.
- f. The criteria listed above are used for comparative assessment and may be weighted as necessary to best meet the Performance Objectives. The criteria are not listed in order of priority.

**19. Reserves**

- a. The Selection Panel may in its discretion nominate one additional athlete as a non-travelling reserve for any individual event. If more athletes satisfy criteria than there are places available, athletes will be assessed using the criteria outlined in the Rounds. There is no obligation on the Selection Panel to nominate reserves.
- b. In situations where an athlete has been de-selected, UKA will exercise its sole discretion in determining whether or not to call upon a reserve.

**SELECTION PANEL**

20. The Selection Panel shall comprise the following Members stated below. A substitute may be nominated at any time by the Performance Director if a member (including the Performance Director) is unavailable:

- a. Voting Members:
  - i. Performance Director;
  - ii. Deputy Performance Director
  - iii. Representatives from each of the Endurance, Sprints and Field & Combined event groups who will each vote on all athlete selections.
- b. Non-Voting Members:
  - i. Chairperson;
  - ii. Event specialist(s), as nominated by the Performance Director if considered necessary;
  - iii. British Elite Athletes Association, UKA Athletes Commission, or another observer (as required)
  - iv. UK Athletics Medical representative (as required);
  - v. Legal representative (as required);
  - vi. Media representative (as required);
  - vii. Note taker(s), and;
  - viii. Any other person invited by the Chairperson.

21. In the event of an actual, potential, or possible conflict relating to any voting member of the Selection Panel, it should be reported to the Chairperson of the selection meeting who shall determine whether the voting member in question should be permitted to take part in relation to any selection decision(s). The Chairperson may appoint an alternative selector if necessary.

22. Voting of the Selection Panel shall be by simple majority. The Performance Director shall have a casting vote, if required. If the Performance Director is unable to vote due to a conflict, the Chairperson shall nominate the Selection Panel member with the casting vote if required.

23. The Selection Panel may make any selection subject to the athlete completing a performance requirement, test set or health/injury assessment.

## DE-SELECTION

24. Following selection, an athlete may be de-selected by the Selection Panel or UK Athletics in the event of:
- a. The athlete ceasing to comply with the eligibility criteria set out in this Selection Policy, or other strategy document or policy communicated by UK Athletics.
  - b. Failure to sign the World Class Programme Athlete Agreement or Team Member Agreement.
  - c. Failure to comply with any conditions set by the Selection Panel.
  - d. Application of the UK Athletics Team Medical Policy as set out in the World Class Programme Athlete Agreement or Team Member Agreement.
  - e. The athlete not complying with any selection conditions set by UK Athletics.
  - f. Any anti-doping rule violation or provisional suspension or failure to complete any required anti-doping action, including training or courses.
  - g. Any serious misconduct or suspension due to misconduct.
  - h. A breach of any UK Athletics policy.
  - i. UK Athletics reasonably considering that the athlete will be unable to perform at the level required or expected due to any reason including loss of form or failure to recover fully or as expected from injury or illness, or:
  - j. Failure to opt-in to team training or events.

## GENERAL PROVISIONS

### 25. Amendment

UK Athletics reserves the right to amend this Selection Policy at any time in its sole discretion and will make any amended version publicly available (including the date on which any amendment was made) at [www.britishathletics.org.uk](http://www.britishathletics.org.uk)

### 26. Governing Law

This Selection Policy shall be governed by and constructed in accordance with the law of England and Wales.

### 27. Jurisdiction

Any dispute or claim (other than appeals) arising out of or in connection with this Selection Policy shall be submitted for determination exclusively to arbitration under the auspices of Sports Resolutions (UK) Limited and subject to the procedural control of the English Courts.

### 28. Appeals

Athletes who have not been selected may appeal their non-selection in accordance with the provisions in Appendix 4 only.

## APPENDIX 1 – GENERAL ELIGIBILITY CRITERIA

1. Be eligible to compete for GB&NI and be the holder of a full and current British passport.
2. If competing in a Female athlete category event, possess a SRY Gene Test Certificate before 9 March 2026. This is in line with World Athletics eligibility rules (Technical Rule 3, Eligibility Rule 3.5).
3. Comply with all World Athletics and competition rules relevant to the category and/or event they wish to compete in.
4. Is not serving a period of ineligibility from the sport (as determined by UK Athletics or a Home Country Athletics Federation) or from any other sport. For example, due to misconduct and/or disciplinary reasons.
5. Not under investigation or been charged by UK Athletics, a Home Country Athletics Federation, or any other relevant organisation (including the police and CPS) with misconduct or any disciplinary, safeguarding or criminal offence.
6. Completed all anti-doping requirements.
7. Not committed a criminal, disciplinary or safeguarding offence that in the reasonable opinion of the Board of UK Athletics renders the athlete unsuitable for selection.
8. Has not, whether by an act or omission, brought UK Athletics into disrepute.
9. Meet the standards and behaviour expected by UK Athletics, as published from time to time, including in the International Athletes Code of Conduct.
10. Be registered as a member with the relevant Home Country Athletics Federation (HCAF), directly or through a club. Exemption may be granted in exceptional circumstances only, where an athlete must be registered to a club in a foreign country due to local laws and regulations governing residency and training. In such cases, the athlete should seek written approval from the Performance Director in advance.
11. Be 16 years or older as of 31 December 2026 (i.e. born in 2010 or earlier), with the exception of shot put (see point 12).
12. Be 18 years or older as of 31 December 2026 (i.e. born in 2008 or earlier) to be considered for selection in the shot put.
13. Sign the UK Athletics Team Members' Agreement ("TMA") or World Class Programme Agreement as applicable and abide by its terms and conditions. Any athlete failing to do so prior to the first date of competition will result in their selection being withdrawn. ## APPENDIX 2 - PERFORMANCE CONDITIONS

The World Athletics Qualification Standards must be achieved in accordance with the Performance Conditions as set out below.

1. Performances must be achieved during competitions organised or authorised by World Athletics, its Area Associations, or its National Member Federations. Thus, results achieved at university or school competitions must be certified by the National Federation of the country in which the competition was organised.

2. UK domestic track and field performances will only be certified by UK Athletics if they are achieved in a UK Athletics Level 2 Permit competition or higher, or in an Area or County Championship (see <https://www.uka.org.uk/competitions/track-field-licensing/> for details on the UK Athletics competition permits).
3. Multiple performances achieved in the same individual event in a single day will only count as follows:
  - a. In a track event - at an official Championship of UK national level or higher and;
  - b. In a field event - only the best mark in the final and best mark in the pool.
4. Performances otherwise achieved in the same individual event in a single day will count as follows:
  - a. In track events - only the fastest legal result of the day;
  - b. In throwing events - only the best throw of the first competition of the day; and
  - c. In horizontal jumps - only the best jump of the first competition of the day, unless every mark achieved by the athlete was windy in which case a second competition held under safer conditions will count.
5. Performances achieved in mixed events between male and female participants shall not be accepted.
6. Wind-assisted performances, or performances achieved at events where wind measurement was not available, for events held completely in a stadium, will not be accepted. For combined events, the conditions set in World Athletics rule 149.3 (or any revised or amended rule relating to wind readings in combined events in force at the time) will be applied for qualification purposes. This requires that at least one of these conditions be met:
  - a. The wind velocity in any individual event shall not exceed plus 4 metres per second;
  - b. The average wind velocity (based on the algebraic sum of the wind velocities, as measured for each individual event, divided by the number of such events) shall not exceed plus 2 m/s.
7. Hand-timed performances in 60m, 100m, 400m, 60m Hurdles, and 100m/110m Hurdles will not be accepted.
8. Performances must be achieved on tracks in accordance with World Athletics requirements.

2. All athletes wishing to be selected pursuant to this Selection Policy agree, as a condition of consideration for selection, that the UK Athletics Selection Fast Appeals Procedure is to be treated as an arbitration procedure under Part 1 of the Arbitration Act 1996 (the "Act") and amounts to a binding arbitration agreement for the purposes of section 6 of the Act. The seat of the Arbitration shall be England, and the Procedure shall be governed by English law.
3. Athletes wishing to commence an appeal should be aware there is a £250 administration fee due upon notice of appeal. The fee is refundable if the appeal is upheld. The fee must be paid in conjunction with the Notice of Appeal, as per the timelines outlined below.
4. The Notice of Appeal will not be valid unless the athlete provides confirmation of payment of the administration fee at or before the time the Notice of Appeal is due.
