## Welcome & Apologies

LD welcomed everyone to the meeting and said apologies had been received from Ed Warner.

### Chairs Report

Chairs report taken as read

Birmingham Institute – NdV confirmed that it was unlikely to happen during the Rio cycle but hopeful for next cycle.

Olympic Head Coach – PE has now been appointed as Head Coach in Canada for both Olympic & Paralympics. The Council wished him well in his new role.

Strategy – A strategy document is being produced which will be shared with stakeholders, this will cover 3 areas – 2005 - 2012 - 2017 with the overall aim "to be the best Olympic & Paralympic sport".

The 5 key strategic areas:

- Best TV Events
- Best Participation
- Best Governance
- Winning Medals
- Put on the Best ever World Championships in 2017

The strategy document will be circulated before the Sainsbury's Anniversary Games

Richard Worth has been appointed as Senior Non Executive Director who will replace John Taylor. The Council congratulated Richard on his appointment. The Council also wished to thank John Taylor on his services to the Board.

## CEO Report

CEO report taken as read

World Indoor Championships 2016 has bids from 2 cities – Birmingham & Glasgow, a decision on the bidding city will be decided in the next 2 weeks and notified to the IAAF.

British Championships – NdV said he was disappointed that the Championships were not well supported by clubs when athletes are running in club vests. BA added that this was partly due to clubs having other competitions on the same weekend. NdV asked the Council for their thoughts on how to build the support from clubs.

The Council wished to congratulate UKA on the challenges faced post 2012 and the achievements in 2013.

2014 Grand Prix – Ideally venue would be London however this is unlikely, but there is a possibility of Glasgow a couple of weeks before the Commonwealth Games. NdV is hopeful of being back in the Olympic stadium for 2015.

European Team Championship - LD said that the feedback from the European Team Championships in Gateshead from European Athletics was very positive. The Council wished to thank the Officials on their flexibility during difficult conditions due to the poor weather.

LR asked NdV with regards to the HCAF funding for 2014 onward. NdV said that this was still uncertain until a sponsor has been agreed.

Birmingham Diamond League – The Council wished to record their thanks to Cherry Alexander and the TV Events team on the delivery of an excellent Diamond League event.

### SMG Reports

Facilities & Health & Safety – BA said the facilities website was out of date. SH to feedback to Michael Hunt to make sure the website is up to date.

## UKA 2013/14 Budget

KT presented the 2013/14 Budget to the Council – A copy is attached for information.

### Council Election

Vice President – A replacement for Steve Backley has been discussed at previous meeting. LD said that he had met with Jason Gardener since his name was mentioned as a possible replacement. JG will shadow LD as UKA President over the next 12 months. RC asked if JG would remain on the Board, LD confirmed that he would step down from the Board if he was confirmed President but would still attend UKA Board meetings. The Council agreed with JG acting as Vice President and therefore will be omitted from Council elections.

Clubs – BA has agreed to step down; KM & MH will be nominated for re-election. If reelected, it will be a 2 years term; if someone else is nominated and subsequently elected then this would be a 4 year term. Nomination forms issued, the deadline for nominations is 6 September.

Road Running – NR will remain on the Council as Road Running representative and the Off Track position will be up for election.

LD wished to thank KT & John Temperton for carrying out the election process.

### England Athletics – Chris Jones/Peter King

Athlete Registration – CJ said that over 90,000 athletes had registered so far which is only around 1,000 down from the same time last year. BA asked that the registration process for athletes could be simplified, he felt that the amount of detail required was too much. CJ added that the information was important as this helped when sending communication to ensure relevance, as well for commercial use.

Youth Development League - The YDL is well through the League season during which five main issues had been raised by the clubs which would be dealt with at a "Review & Reflect" meeting of YDL clubs on Saturday 30 November when these matters could be considered and 2014 rules changed if thought necessary. These were:

- League structure and travel distances
- Shortening timetabling set against requests for more non-scoring athletes
- Re-sequencing events.
- Lack of officials supporting meetings from host and visiting clubs.
- Shortage of athletes in certain events (notably steeplechase, 3000 and pole vault) which Mike Heath and I have been discussing with Peter Stanley since June

# Appendix I England Athletics Report – Chris Jones

## KEY HEADLINES JULY 2013 HEADLINE UPDATE

- 13-17 contract now signed and first payment received.
- Active People Q7 results received during June. Participation down in running 1x30 mins a week but up by 23,000 in track and field showing 2012 impact and effect. Athletics has met its 4 year target for participation during the 09-13 period. CJ to explain more at UKMC.
- 13-14 internal operational plan and delivery budget now in place and driving our local staff work.
- 1<sup>ST</sup> RUN GROUP held in London 4th June involving private/commercial running providers to drive forward our recreational running strategy over the 13-17 period and to provide an insight function for the running market. CJ to explain more at the UKMC meeting regarding this concept.
- There are currently circa 45,500 Run England members and 2,750 registered Run England groups across England including over 100 registered marked running routes.
- We have secured an additional £35k from the FA to support our inner London Activation project. We are in the process of applying for further financial support from the GLA to complement our existing 12 borough wide activation work. This project delivered 120,000 participants as a result of a focused 2 year pilot project and has now been expanded into the 13-17 period. This model is being used as a blueprint in other major English cities.
- Peter Stanley is now in place having replaced Richard Wheater as Head of Coaching & Development. Richard has now left the NGB and Peter reports to both UKA/EA boards on coaching. Peter's priorities include completing the UK wide coach education review and in driving forward the joint coaching strategy between UKA and EA.
- 5 event group leads are now in place as part of the joint coaching department cross UKA and EA. These guys are leading our coordinated strategy and are managing coach/athlete development strategies from top to bottom (and are working closely with the respective home country leads)
- The UKA led coach education review continues with advisory panels being set up to input to the process as well as individual interviews and user groups. An online survey rendered circa 2,000 responses thus far. This is due for completion by the early Autumn. EA is supporting this process but it is being led by UKA.
- 100% of the Athletics Network grant panels have now convened across England with an average grant of between £5-10k being awarded in each instance towards delivery of plans. Key activities include running participation, satellite clubs and coach education.
- Each of our 4 area teams has a budget now for coach education subsidies targeted at 14-25 year olds in line with our WSP. Some of this funding is being used to support network plans for education.
- 10 annual consultation events have were held with an average attendance of between 25-50 people at events. Nearly 2,000 online surveys completed and follow up 1:1 interviews are being conducted now with club representatives. 10 meeting summaries published on the EA website for viewing. The focus of the 2013 consultation process was affiliation and governance. CJ to update UKMC on this at the meeting.
- Regional club conferences will be held across England during Autumn/Winter 2013-14. These will be led by our regional councils and local delivery staff to meet the needs of local clubs.
- Planning has commenced for the 2013 National coaching conferences which will be held on 28 & 29 September (28 Leeds and Lee Valley, 29 Birmingham). The theme for this year events will be "pass it on! – mentoring in action" and an increased number of NCDP mentees will be involved to facilitate practical workshop, share their experiences of mentoring and form

new links with local coaches. All UKMC members are welcome to attend any of these!

- Affiliation payments continue to come in for the 13-14 year with 87,000 athletes registered thus far (132k final baseline in 12-13). A further circa 3,000 Under 11s have also been registered during this time (new venture) alongside over 1.3k clubs and organisations (ahead of 12-13 numbers) Athlete Packs are going out at present including promotional offers from UKA commercial partners.
- Regional Volunteer Award nominations and Hall of Fame voting continues with regional award ceremonies taking place from September onwards our 6th national HOF and Awards evening takes place on 19 October in Solihull. We expect between 500-600 guests to attend this celebration.
- Commonwealth Games standards, selection and appeals process plus an overall project plan have been developed with our management team assigned to lead this work. Many athletes have so far met the A and B standards. We have secured additional athlete development support funding from Sport England and are now looking closely at our requirements for holding camp finance in the lead towards Glasgow.
- We are working with UKA on their own facilities strategy at present and will ensure the EA document compliments and links into this.
- Work on site at Stoke Newington School is underway and the next project steering group is taking place on 6 June. Some issues have arisen over the project costs, which are now approximately £4K over the level of funding that is available. Key partners are aware and this will be discussed and resolved on the 6th, along with details of the opening for the site and finalising of the development and business plans.
- Briefly mentioned above but we are working closely with Sheffield CC / Liverpool CC / Nottingham CC / Manchester CC on specific T&F facility developments in these core cities
- 25 counties registered for grants for their Championships with a contrasting number of requests such as EDM, Photofinish, Technology for officials, clothing and support for officials, promotional and marketing resources etc.. Reports from the events are coming in slowly, the more positive the quicker the reaction time! Expect to have a fuller picture for the next meeting with some recommendations for any future activity.
- June 2-3 saw a "4 in 1" competition take place including EA Senior &Under 20's CE's, 42 Senior men entered, (*first time we have put a qualifying* STD *on a combined events for years!*) Event also includes a cancelled UKA disability event re branded as 'England Open' this has attracted 200 entries from over 130 athletes!! Also included were a number of Under 18 qualifying events for the World Youths and finally England will host a Home Countries Throws International, labelled the Alan Bertram Memorial International in Alan's memory - this has attracted a further 86 of Britons throwers.
- Our national disability champs took place as part of the Midlands Counties track and field champs during June. A huge success.
- Under 20-23 Championships were again a success with numbers holding at the last few years high levels, in fact there were semi-finals for the 1500m's in the first draft of the timetable! However a poor entry had been recorded on all sprint hurdles. Andy Day is working with our Sprints NCM and Head of Coaching & Development to better understand the reasons for this.
- We ran an educational day for our CCSOs on the Friday before the above Championships with presentations from Peter Stanley, Dave Sunderland and Andy Day, this on the back of the success of the day that was provided for 30 coaches and team managers held before the Loughborough International in May.
- Our senior champs take place this weekend as part of an integrated British Championships
- The ESAA Track and Field Championships were yet again a huge success. EA is funding these for the 13-17 period and continues to work very closely with the England Schools Athletic Federation.

## **Major Events**

- The bid to host the IPC European Athletics Championships in Swansea in July 2014 was successful and the LOC is now focused on delivery. The Local Organising Committee is comprised of Swansea City Council, Swansea University, Welsh Government, Disability Sport Wales, Welsh Athletics and UKA.
- A successful World Trail Running Championships was held in Llanrwst on 6 July 2013. Following a rousing opening ceremony at Venue Cymru, Llandudno on Friday 5 July, athletes descended on the picturesque Gwydyr Forest to complete the 77k race. - **3.** A green light has been given to bid for the World Mountain Running Championships in Llanberis, Snowdonia in 2015. The business plan seeks to link the WRMA World and Masters Mountain Running Championships over a 7-day festival of mountain running.
- 4. Finally, Cardiff has been nominated as the UK entry to host the World Half Marathon Championships in 2016. Unfortunately, the IAAF has insisted that the Championships are held in March, which prevents a link with the existing Cardiff Half Marathon (6 October). Initial discussions have been held with Welsh Government and Cardiff City Council to establish the LOC and to proceed with the bid.

## **Domestic and International Competitions**

Following a damp, but successful Under 17 and Under 20 Welsh National Championship in Swansea on 22 June, the spotlight shifted to the capital city for the Senior National Championships on 29 & 30 June and then for the Welsh Schools Athletic Association's National Track and Field Championships on 6 July, part of the multi-sports Gemau Cymru (Welsh Games).

The Cardiff International Sports Stadium will also see the return of the Welsh Athletics International on Wednesday 31 July, a high-calibre international track and field meeting featuring teams from the home nations.

Looking forward, this Championship season marks the start of the twelve-month selection window for the 2014 Glasgow Commonwealth Games, with qualification standards now published on our website.

### **New Starters**

Welsh Athletics are pleased to announce the appointment of three new staff members in Club Network positions.

Jessica Huddleston will be covering West Wales/Dyfed, Joey Duck will cover the Glamorgan Valleys area and Steven Boyles will look after the area covering South East Wales.

The focus of these positions will be to deliver the primary objectives of the new Athletics Networks - Club Development Plan, to support the growth and development of the sport over the coming years.

These appointments now provide consistent coverage to all 8 school districts in Wales.

### Appendix III Scottish Athletics – Leslie Roy

#### 1. Board members recruitment.

With the resignation of Julia Bracewell from the Board of scottishathletics we went public with an advertisement and had an excellent response. The chairman and CEO met with 5 candidates who stood out offering some very strong skills and experience that would add to the current board strengths. From this scottishathletics will be offering a position on the Board to two people.

2. Athletics Inspires 2014 – Talent ID. There is funding from Scottish Government as a follow up to the Cashback funding we have previously utilised. This programme focuses on schools especially, with a specific Talent ID programme. scottishathletics' aim is to create and deliver an innovative and exciting programme in order to identify and develop pupils with potential who are not currently involved in the athletics club structures, the ultimate aim to identify young potential who could become next generation of international athletes along with those currently in the system. We will focus on power events (endurance reasonably well taken care of) and every one of the 376 secondary schools in Scotland were invited to send along 3 male and 3 female S3 students who are not currently involved in an athletics clubs with 350 applicants being tested over week beginning 10 June in regional centres and a further 100 being identified through schools T & F championships where clashes existed.

Athletes who are identified based on the tests below will be supported to work with an experienced coach who will be able to facilitate their development and will also be part of a national programme with National Talent ID Gatherings where they will have the opportunity to speak with, spend time with and be mentored by International athletes. Those not selected will be invited and directed to a specific contact within their local athletics club.

Tests will identify talent in the power and speed events including: 30m sprint / Standing Long Jump / Overhead Shot / Batak Board / Three Spring Jumps / Cricket Ball Throw

3. **G2014 Officials.** All officials for the Glasgow Commonwealth Games have now been identified. The names are now being forwarded by G2014 to IAAF for ratification. It is also important to recognise that an appointment to Glasgow Commonwealth Games is not a reward for long and dedicated service - it is to perform a key role under pressure and with the World watching.

- 4. G2014 Test event. It has taken time for G2014 to be in a position to discuss the options of a "Test Event" ahead of the Glasgow Commonwealth Games. We have been pushing the concept on a number of fronts Hampden Park is a temporary venue which brings some unique challenges and a test event maybe the only occasion that athletes other than the CG competitors get to experience competing at the venue a potential memory for life for some. There will be further discussions but we are optimistic that the Scottish Schools Athletics Championships will be deemed an appropriate Test event. SSAA are in support of that proposal and concept, and have also got the understanding that if it does happen, then there is likely to be aspects that will change from the norm in order to meet the test event requirements. This event should give many young people the chance to compete at the same venue as Jessica, Eilidh and Usain a once in a lifetime for many. Eight members of G2014 Staff visited the Scottish Schools Championships at Grangemouth on Friday 7 June to look at that event and get a real understanding of how it would act as a test event. Those discussions were positive, and we expect decisions later this summer.
- 5. Club Together Programme. Consistent with our annual business plan, we have "gone to the market" seeking interested clubs to expand the Club Together Programme if funding is secured via our partners sportscotland. Timing is good, in that we seek interested parties as we published the year's figures very impressive in terms of RETENTION of athletes, coaches and volunteers. These figures are on our website the story is added to the back of this report since the figures do mark this programme as being extremely successful.

We have received interest from 12 clubs in joining the Club Together programme from later this summer, and the detail is currently being worked up to ensure successful "business cases" being presented for support to sportscotland Regional Partners. We would anticipate this reducing to 9 or 10 for presentation to sportscotland.

6. Emirates Arena – Winter dates and approach. There has been extensive discussion and dialogue with Glasgow Life regarding the booking and management of the Emirates Arena for the winter 2013-14. Those discussions build on the experiences of the winter just gone. Nigel Holl has led the dialogue regarding bookings – on behalf of not only scottishathletics, but also Scottish Schools, the Universities and Colleges, and the Indoor League. Those discussions have resulted in a confirmed winter timetable – integrated with Basketball and other sporting events using the arena. Work continues with clubs to seek their commitment to the venue – regular bookings rather than waiting for inclement weather.

### Appendix IV Clubs – Bill Adcocks

As always the period since the last UKMC has been a very busy one on a number of fronts. The rumblings of the eligibility of some athletes from the winning team in the ECCA Cross Country relays and the ERRA National Road relays created much concern, so much so that at the General Committee of the ECCA on 13 May a proposal was discussed and voted on to restrict the number of Foreign Athletes that a club can have in its scorers for the team Championships at the English Nationals. A number of proposals were considered and finally it was carried that a maximum of one foreign athlete would be able to count for a team. This does not preclude a club entering as many such athletes as it has registered. There was a feeling that the option that no Foreign Athletes could score should have been an option but as this was not on the order paper, amendments on the day were not allowed.

The English Road Running Association were in attendance at the ECCA meeting and will consider the situation for their relay championships.

It is anticipated that the ECCA will be making a proposal re foreign athletes for consideration by the rules revision group for inclusion in the 2014 rule book.

It has to be said that all of the above would not have taken place if rule 5 (6) had not been amended for the 2012 edition of the rule book. By taking out the requirement for a residency period prior to a competition because as it stood it was difficult to administer interpretations of the rule crept in which were against the ethos of the rule.

On the same matter of foreign athletes there has been the on-going situation arising from the disqualification of the winning team in the North of England Men's 6 stage Road Relays last October. Without attempting to revisit the whole situation, it has to be said that Clubs are not happy that the reasons why the final outcome was a reversal of the event referee's original decision have not been put in the public domain.

The much lauded Youth Development Leagues will have completed for the lower age groups by the time of this meeting, with the upper age groups having one fixture to go. It has been an interesting exercise but not without its problems. These will vary from club to club but it will be interesting to see the outcomes of any end of season appraisal. The main problems could centre around travel distances and times, duration of the meetings, officials and the condition of some of the facilities.

On the first point consider Notts AC UAG Midland Premier 2 – travel to Yeovil - round trip 406 miles and total time 7 hours plus for a meeting starting at 1015 and finishing at 1755. Notts again LAG Midland Premier 1 – travel to Cardiff – round trip 318 miles and a total time of 6 hours for a meeting starting at 1100 and finishing at 1700. It might be considered that this is one particular club but I would not think that this type of situation does not apply to other clubs throughout those involved.

Some facilities appear to be struggling with the upkeep and it shows. In the Midland League (seniors) the first meeting for division 3 was cancelled because the track to be used did not have a valid certificate. The track in question now has a certificate (B grade) and a YDL LAG meeting took place with two events not taking place due to the certificate not sanctioning them and another event not covered by the certificate, taking place.

On the matter of track certification the UK website information on this matter is somewhat out of date for some items.

# Appendix VI Coaching - Keith May

Some concern was raised over the change of date of the County Championships, with many fearing that it would mean a drop in entries. This, in general, does not appear to have happened and some Counties actually showed an increase in entries. The increase in entries seemed to have mainly come in the younger age groups. This may of course have come as a result of the increase of interest after the Olympics.

I attended the two England Athletics consultation seminars held in the South East. It was interesting to hear the diverse views of people attending and many of those attending were positive. The full feedback from all the consultations has now been released.

The Youth Development League has now had three rounds with good support for both the Lower Age Group league and the Upper Age Group league. The Upper Age Group league timetable was sensibly amended after the first fixture, after feedback received from Clubs. This new timetable was for Clubs outside the Premier Divisions. This has reduced the length of the meeting by approx. 2 hours, which has made a huge difference to the Clubs affected. It will be interesting to see the feedback from Clubs at the end of the season.

## Race Director Courses:

Since the last Members Council meeting an Accredited Race Directors Course has been held in Birmingham and two Intermediate Courses held in, Scunthorpe and Crystal Palace.

## **Road Race Licence Applications:**

We have seen the introduction of the flat rate fee for affiliated clubs of £25.00 introduced and an increase in the banded fees for other organisers. As a result a lot more money remains within the road running club structure. Wales has adopted this and the appointment of Event Adjudicators.

Licenses to date stand at 1,337 (total for last year - 2,013) We currently have 295 races using the online entry system (total for last year - 325)

We now have 285 Event Adjudicators covering 296 roles (some work in more than one region)

Over 35,000 have claimed their Handicap Scores

**Website:** This was re-launched on 1 May after many delays; most of the inherent problems have now been ironed out. Thanks to Gavin Lightwood and Adrian Thiemicke for all their sterling work during this process.

**Race Organiser:** Also launched within the website makeover is a new tool for race organisers, a fully integrated mapping and reporting system.

**Surrey County Council:** Having attended a meeting with John Temperton at the request of Surrey County Council to discuss events on the highway, it is pleasing to report that they will ensure that all road running events will need a UKA Road Running Licence. We also agreed to work more closely on a monitoring system to identify other events not currently hold our licence and will also input into their Event Organiser Guide, currently in draft.

**Rules:** The Technical Group will be putting forward a number of changes to rules and seeking the inclusion of an Endurance Appendix that will cover the roles and responsibilities of officials, and definitions (disciplines) etc.

## UKA Endurance Advisory Group:

A couple areas of work currently being undertaken;

Definitions – This is providing a clearer understanding of road, multi terrain and trail events definitions.

Officials Handbook is in final draft, this will cover road running and cross country elements.

Michael Hunt is providing a Health and Safety paper as a result of recent incidents at races; this will include participants taking supplements.

### **England Athletics:**

Run England – Number of Groups stands at 2,313 Number of Runners stands at 47,303

Chapter 8 Courses – Are continuing on a regular basis and a new 4 year contract for these and refresher courses are being agreed. Accreditation for this will be added to UKA Officials Accreditation.

Commonwealth Association of Mountain and Ultra distance Running:

No tenders have been received to stage the 3<sup>rd</sup> Championships in 2015.

### Ultra Distance Running:

Ricky Lightfoot GB took 1<sup>st</sup> Male at the 4<sup>th</sup> IAU Trail World Championships held in North Wales on 6 July, in a time of 5:36:03 (75km).

## Appendix VII Coaching Mike Harris

Since my election some six years ago, the area of coaching has been pivotal to UKA strategy.

In my experience (i.e. since 1980 when Max Jones passed me out as an Assistant Club Coach ) it has never had a higher profile.

The emphasis on coach development has been the right thing to do and I have personally seen the evidence of this from the Masterclass programme & international conferences right down to the Local Coach Development Programme, which continues to develop.

The area of coach education has trod a more difficult path and is currently the subject of an independent review. Much work has been done on this but more still needs to be done and this area is currently a main agenda item at home country level. Aside from logistical problems such as cost, tutor quality & availability, course dates, etc, where it is always going to be difficult to satisfy every individual, the main focus has to be on the coach education syllabus and it's structure.

Throughout this period, there have been probably three key players heading the coaching strategy; Callum Orr initially ; and then Kevin Tyler & Richard Wheatear until recently. What is now required is further stability.

I was on the interview panel that lead to the recent appointment of Peter Stanley as Head of Coaching.

Peter is a well-respected coach at all levels, who knows the domestic scene very well but who has a massive area of responsibility. He has already listed his priority areas but with his role as leader of the England Commonwealth Games team and his additional area of domestic competition strategy, it will require some monitoring to ensure focus & direction is maintained.

I have offered to meet with Peter to discuss domestic competition strategy in particular as this area still has a lack of direction, strategy and vision and is plays a key part in coach development.

This season I have attended UK League matches (including Edinburgh with 3 – 500 spectators for Jess Ennis's planned appearance), Upper & Lower YDL matches, Northern League matches and the European Team Champs, all team competitions.

I have also attended championships, Grand Prix and other individual events.

Without doubt the most enjoyable are the team competitions, from a spectator point of view and, I would argue, an athlete's point of view.

It is clear that such competition is crucial to the athlete development pathway, and, therefore, the coach development pathway but this has not always been acknowledged by the coaches who contribute to the domestic competition pathway. These coaches are outside the club system as they are mainly focussed on elite athlete development – their views are needed but not as strategy setters.

I look forward to discussing this with Peter

## Appendix IX Officials – Wendy Haxell

### Education

A deadline for Health and Safety has been issued so that regulations regarding long throws will be fully enforced.

After 30 June 2013 any official at level 2 or above (Track judge, Field judge, Timekeeper, Starter, Starters Assistant, Photofinish Judge) that has not completed the health and safety module would only be able to assist a qualified official **until** they had completed the Health and Safety course

A new record of experience has sent out to all officials with instructions on its use depending on the official's level.

Level 3 questions are now on the website and have to be submitted and marked before any application can be considered.

Education coordinators are likely to be appointed for each region.

### **Summer fixtures**

The England Combined events with some paralympic events was a success. The general atmosphere was enhanced by the additions.

The European Team Championships was hailed a success despite the weather. Opportunities are still being given to develop officials in major roles.

### Statement from European Athletics President Hansjörg Wirz

The bar has certainly been raised at these excellent European Athletics Team Championships in Gateshead.

We are very happy to see how the people of Gateshead and the North East have embraced these unique national team championships.

The stadium has been packed out rain or shine with spectators who have created a memorable atmosphere over the last two days. It has been great to see such a historic sporting venue as the Gateshead International Stadium provide excellent facilities where the athletes could compete to the best of their abilities.

We have received very encouraging television audience overnight figures for Saturday's coverage on BBC One, with an average audience of 1.6 million, peaking at 2.4 million, with a 14.5 percent market share.

The passionate fans at the stadium and the millions watching at home have showed how well received athletics is in Great Britain, and that the momentum that our sport picked up during the London 2012 Olympics has been maintained.

The organisation of the championships has been excellent. Partnered by UK Sport and the IAAF Regional Development Centre in Moscow, the seminar will be held annually in Britain for the next four years.)
