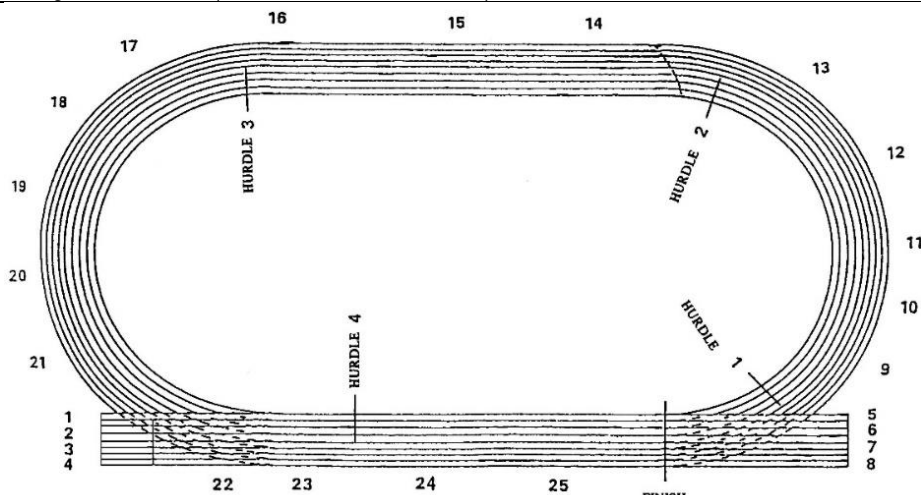

| <b>18.7</b>     | Cutting in too soon at the break line   |

## **NOTE:**

### **Lane infringement "L":**

**Ambulant athletes:** one step (touch) allowed.

**Wheelchairs:** L can be applied when the duration for which the wheel of the racing chair making contact with the line remains in contact with the line does not exceed the time that it takes the athlete to make [two] further pushes on the push-rim of the racing chair from the point at which the wheel of the racing chair first made contact with the line

**Frame Running:** L can be applied when the duration for which the wheel of the Frame Runner making contact with the line remains in contact with the line does not exceed the time that it takes the athlete to make [two] further steps from the point at which the wheel of the Frame Runner first made contact with the line.
