

UK ATHLETICS TRACKMARK REACCREDITATION

Overview

The initial TrackMark accreditation process assessed compliance against the 4 mandatory TrackMark units (1-4):

- Unit 1 Track surface
- Unit 2 Field events
- Unit 3 Ancillary facilities
- Unit 4 Operations

Optional Units 5 & 6

In addition, optional units 5 (Floodlighting) and 6 (Competition), assessed compliance for those venues that sought to hold events under lights and/or UKA license level 2 events (regional /national).

Reaccreditation

The reaccreditation process is much simpler **and focuses on Unit 1 - Track and 2 - Field only** (*Plus Unit 5 if sports lighting accreditation/reaccreditation is required at a venue*).

WHEN TO REACCREDIT?

To provide flexibility to venue operators, the mandatory Unit 1 (Track) and Unit 2 (Field) inspections can be carried out <u>up 3months before and 3months after the expiry date shown</u> <u>on your original TrackMark accreditation certificate</u>. Note: The original accreditation anniversary date will be preserved.

TrackMark status at the venue will be maintained for a further 3 years as long as:

- Inspections take place within the 6month reinspection window.
- All relevant inspections achieve a pass grading.

For reaccreditation, the company(ies) that you select to carry out your inspections will automatically upload the resulting TrackMark inspection report(s) to a secure online area where it can be immediately viewed and assessed by UKA.

IMPORTANT: If Unit 1 and Unit 2 inspections are not carried out and submitted within the 6month accreditation window or, if a Unit fails its reinspection, then the venue will lose its Trackmark status and the ability to host licensed competition.

UNIT 1 – TRACK SURFACE

How to reaccredit

Contact one of the two World Athletics/SAPCA approved consultants (below) to commission a Unit 1 TrackMark inspection:

Once the inspection has been carried out the resultant report will be uploaded to a secure online area for review/assessment by UKA.

UNIT 2 – FIELD

How to reaccredit

To reassess the condition of the field events/equipment, UKA requires that ALL field events available at the facility are inspected a Sport & Play Construction Association (SAPCA) / UKA approved company and that a cage load test for every cage at the venue is carried out by an approved testing company.


Note: Please ensure that you commission a company(ies) that can carry out ALL the relevant field inspections at your venue.

UNIT 2 REQUIREMENTS

Requirement 1	Notes
For venues with a cage(s) a visual inspection of the condition of the shot circle, throws cage, netting and circles must be carried out by a SAPCA/UKA approved company	Commission a unit 2 field inspection from an approved company.
Requirement 2	Notes
In addition to the above visual inspection a throws cage load test must also be conducted by a SAPCA/UKA approved company	Commission a Cage Load (stress) test to be carried out by an approved company.
Requirement 3	Notes
For venues with a Pole Vault facility a recent landing bed inspection report must have been carried out.	Commission a unit 2 field inspection from an approved company.
Requirement 4	Notes
For venues with a High Jump facility a recent landing bed inspection report must have been carried out.	Commission a unit 2 field inspection from an approved company.
Requirement 5	Notes
For venues with a Long /Triple jump facility a recent safety inspection report must have been carried out.	Commission a unit 2 field inspection from an approved company.


Note: All Unit 2 inspection reports will automatically be uploaded to UKAs TrackMark portal for review/assessment

Unit 2 Field inspection (All field events): UKA/SAPCA approved companies



The two companies above are both authorised to carry out TrackMark Unit 2 reinspections of ALL field events: Throws cage/circles, shot put circles, horizontal jumps and vertical jumps.

Unit 2: Throws cage structural load test – UKA/SAPCA approved company



Labosport and Sportlabs are the two SAPCA/UKA approved companies authorised to carry out structural throws cage load tests.

UNIT 5 – SPORTS LIGHTING

To successfully accredit/reaccredit Unit 5, the illumination levels and uniformity for BOTH the track circuit AND the infield/outfield must be independently checked and the following minimum levels achieved:

*Class I: 500lux average, 0.7 uniformity - International/Premier competition venues *Class II: 200lux average, 0.5 uniformity - Club training and Level 2 licensed competitions *Class III: 100lux average, 0.5 uniformity)- Club training and Level 1 licensed competitions

To assess the sports lighting of track circuit and field events UKA requires that an independent sports lighting test is conducted by a <u>SAPCA</u> approved, World Athletics accredited test house every 3years - see below for approved companies:

Unit 5 – Approved companies



UNIT 6 - COMPETITION

No action is required unless your track has been fully resurfaced in which case, we will require a new measurement and level survey to be carried out by a SAPCA/UKA approved surveyor.

Contact <u>UKA</u> for a list of UKA approved track measurement surveyors.

REACCREDITATION FEES

Once your reaccreditation inspection reports have been carried out and assessed UKA will issue an invoice for Unit assessment fees – these remain at £75 per unit.

For example, a venue reaccrediting Unit 1 and Unit 2 will be required to pay £150 unit fees.

Note: Venues formally managed by EA/SA/ANI/WA affiliated Athletics Clubs are exempt from unit fees.

FREQUENTLY ASKED QUESTIONS

I can't find my original TrackMark certificate.

No problem just email: <u>TrackMark@uka.org.uk</u> and we will email you a copy of your certificate and award letter.

What about advisories on my original TrackMark award letter?

UKA will review the reinspection reports and assess whether relevant/appropriate action has been taken to address any advisories raised in previous inspections.

How do I submit my reports?

The reaccreditation process has been streamlined to make it much simpler and <u>you are no</u> <u>longer required to upload your reports to a portal.</u>

Instead, once an inspection had been carried out the inspecting company will automatically upload the report to a secure online area for assessment by UKA.

How do I know if the inspections have passed?

The [¥]main point of contact at the venue will receive an email confirming that a Unit has either passed or failed plus any advisory notes.

Will I receive a new certificate?

Yes, once Unit 1 and 2 reinspections have been completed and assessed as compliant a new certificate and award letter will be emailed to the [¥]main point of contact at the venue.

What about Units 3 and 4

Whilst Units 3 and 4 are not part of the formal reaccreditation process, we would be grateful if you could inform us of any material changes to your original Unit 3 and 4 submissions so that we can update our records. Email: <u>Trackmark@uka.org.uk</u>
